Once the file is in SharePoint, you can configure CB Blockchain Seal for SharePoint to seal it automatically (based on the folder or file type, for example).

Each sealed file has a corresponding timestamp, which is important for compliance. Plus, from the moment each file is sealed, it can be verified at any time, from anywhere - either from CB Blockchain Seal for SharePoint, which will present the list of files in SharePoint, or from CB Blockchain Seal Verifier online. The verification process ensures the file remains immutable since sealing.
